4. GENERAL UPDATES AIR FILTERS & PUBLICATIONS/STANDARDS

4.1 Factsheet Air Filters

Discussion goes into the Eurovent publication, which has been released recently. Peter indicates that it could be translated in Dutch and that this would be very useful.



It also depends on the application, light or heavy application. Dirk summarized and asks about what we want to decide to do. We could make a separate publication. Peter indicates that all content is already in sight.

Peter shares the screen with the attachment 2. about Filter Recommendations from Eurovent. Peter goes deeper through the document and explains some of its components. The document will already be translated into Spanish, German, Turkish, French?, that was indicated in an Eurovent meeting that occurred two days ago.

Frans also thinks it's better to have separate documents.

Johan asks if it's allowed by Eurovent to Dutch, and Peter says they even recommend it. Then afterwards we can give it to them. Only the text would be required, the layout would be done by Eurovent.

Peter says Eurovent also has a similar file for particle filters. Peters main focus is if we can still reach the people with it, or whether the people would just go to Eurovent.

Dirk Heimans ask what the disadvantage for making a Dutch version, people say there aren't many disadvantages. But if Eurovent does it, we don't have to do it. Translation has the preference over an own book. Peter can contact Andrea about what format she wants to have. Peter can do the translation. Dirk Heimans asks if the translated file can be first shared in the group and Peter agrees.

Dirk Noordmans summarizes it: Peter approaches Andrea first and works on the translation. Then sends it towards the group.

4.2 Campaign PvE Healthy Offices

Jules explains the pilot campaign that was run in order to promote the PvE Healthy Offices. A pilot marketing campaign was undertaken to create more exposure and increase awareness about the products we have available at Binnenklimaattechniek.

Peter also talks about a previous campaign from 2023 called 'Air is Food'. Peter and Yanbin elaborate a bit further about that previous campaign. It was a campaign for the importance of clean air.
