Decision 2020-09 taken by CEN/TC 371 on 2020-12-15

CEN/TC 371 agrees to create a Chair Advisory Group, EPB CAG, for advising the chairs of the respective TC's that would work the new EN 16798-1 suit of standards.

CEN/TC 371 further agrees that the members of this EPB CAG are the Chairs and Secretaries of the TCs involved, plus the respective Project Managers from CCMC.

It is decided that the CAG should not interfere with the technical work or decide on specific standards, but rather steer the work and ensure a smooth coordination among the TCs.

Hogeling and Van der Horn expressed willingness to act as convenor and secretariat.

A CIB for appointment of the Convenor would be conducted after consultation with CEN/TC 156.

The decision was taken by unanimity.

Decision 2020-10 taken by CEN/TC 371 on 2020-12-15

CEN/TC 371 agrees to create a new Working Group, WG 2, for the possible development of EN 16798-1-1, which is the overarching part, and would be a partial replacement for EN 16798-1.

CEN/TC 371 agrees that the members of this WG 2 together should represent all technical topics of the new EN 16798-1 suit of standards and represent all TCs involved in the revision of EN 16798-1.

A proposal for creation of a new working item and appointment of convenor and coconvenor would be conducted after CEN/TC 156 request this of TC 371 and hands over this work item to TC 371. DIN expresses interest to host the Secretariat for this new WG.

Seifert is proposed as Convenor, Olesen is proposed as co-convenor.

The decision was taken by unanimity

(Note that since the EPB CAG will be WG 2, the WG above will be WG 3.)

Decision 2020-11 taken by CEN/TC 371 on 2020-12-15

CEN/TC 371 agrees to create a new Working Group, WG 3, for the possible development of EN 16798-1-2, which is the thermal comfort part, and would be a partial replacement for EN 16798-1. CEN/TC 371 agrees that the members of this WG 3 together should represent all technical topics of the EN 16798-1-3 and represent all TCs involved in thermal comfort.

A proposal for creation of a new working item and nomination of convenor and co-convenor would be conducted after CEN/TC 156 request this of TC 371 and hands over this work item to TC 371.

The German delegation will ask DIN to host the secretariat for this new WG.

Seifert is proposed as Convenor, Olesen is proposed as co-convenor. The decision was taken by unanimity.
